7. WINCHESTER CITY COUNCILLOR'S REPORT.

8. SPEEDING IN THE VILLAGE.

Members discussed the SLR's, there were nearly 15,000 vehicle movements in an easterly direction exceeding 34mph during the 14 day period. This seemed low in comparison with previous readings. Cllr. Sumner thought that the equipment had not been working correctly as there had been a problem with the battery. The Parish Council will try to obtain information from the Police on how many prosecutions result from the visit of their speed check vans. Our local Police Constable PC David Fry stated in his email that the speed camera van visits BS on average 3hours per month and he suggested that Community Speedwatch could be set up. We know that this route is very expensive e.g. Recently set up in Petersfield at a cost of £4,750.

However David did offer to visit BS with a speed gun.
