7. WINCHESTER CITY COUNCILLOR'S - MARGOT POWER, RUSSELL GORDON-SMITH & FIONA ISAACS.

Cllr. Power/Russell Gordon-Smith and Cllr. Isaacs had sent reports which had been passed on to Members.

Cllr. Power had sent an email re septic tanks. This contained details of offers to replace systems and questions to ask the companies when considering a new system. Cllr. McIntyre said that Sophie Evingar was also following this up.

Cllr. Power also referred to developer phosphate credits.

HCC had sided out the path down to the A31 roundabout and left some detritus at the side. Cllr. Parker stated that it had been tidied up.

Cllr. Macintyre said that Helen Clarke's launch of the chalk stream project had gone well. Cllr. McIntyre had received correspondence relating to water concerns in the village and had produced a paper setting out what the PC is or is not responsible for, the role of each Parish Councillor and contacts regarding flooding etc.

10. HIGHWAY MATTERS - Clir. HUTTON.

Cllr. Hutton had stated in his email that he had nothing to report under his agenda items. Water Lane – a resident Amanda Skinner was concerned about flooding in the road which because of the reduction in size of a verge between the road and her property, has resulted in flooding in the drive of her house. The resident claimed the verge has been reduced in size by vehicles running over the edge and the weeds have been cut recently from the top of the verge. The Chairman explained that he had asked the Lengthsmen to cut the top of the verge now as the next visit was not until June. After further discussion the Chairman stated that he will measure the verge.

The lengthsmen found some black bags of rubble left in water Lane from a recent development.

12. INDUSTRIAL PLANNING &SUN LANE DEVELOPMENT - CIIr. PARKER.

AP said that the application had been approved with Tichborne Down being the agreed route.

Hampshire Highways had dropped their objections, and the development could now proceed, possibly in the Spring. There were objections to the size and siting of the industrial buildings.
