# 7. WINCHESTER CITY COUNCILLOR'S – MARGOT POWER, RUSSELL GORDON-SMITH & FIONA ISAACS.

Cllr. Gordon - Smith referred to the Local Plan consultation. This can be viewed through the website however it has 400 pages. A flyer had been received by the Clerk who has been asked to take a photograph and submit it to WCC.
