13. WEBSITE/FACEBOOK.

14. HIGHWAY MATTERS.

Cllr. Sumner was absent. However the Clerk had passed on to HCC Highways the concerns of residents of Mill Lane accessing the B3047 and requesting assistance to make it safer. A reply had been received to say the site had been visited, some signs had been cleaned and a further warning sign would be erected to warn motorists.

15. FOOTPATHS.

Cllr. Nankivell mentioned the grass cutting programme. The Clerk had spoken to Cllr. Humby about a variation to verge cutting where instead of one swipe the grass cutters had recently cut back all the way to the hedges which left a lot of litter and highway signs and cones.

The local Riparian landowners were discussed because as Winter approached it was vital that the ditches are cleared to prevent flooding. The Clerk will forward the standard letter that is normally sent round by WCC/HCC and the Chairman will prepare a letter for local landowners.
