HAMPSHIRE COUNTY COUNCILLOR - ROB HUMBY.

Cllr. Humby had sent a report which had been passed on to Members.

WINCHESTER CITY COUNCILLOR'S – MARGOT POWER, RUSSELL GORDON-SMITH & FIONA ISAACS.

Cllr. Power/Russell Gordon-Smith had sent a report. Cllr. Power mentioned the Alresford footpath, she had spoken to Karen, and it was hoped that the important sections of the path would be refurbished.

With Sun Lane the Construction Plan had been chased. The time scale for the work was unknown.

The 20mph proposal was discussed and the 40mph reduction on the road out of Alresford. There were funds available for cycling and walking.

5. RESIDENTIAL PLANNING – Cllr. Parker
 22/00531/LIS Mr & Mrs Greenleaf. The Mill House.

Minor interior alterations, all listed.

In view of the date for comments being prior to the PC meeting date Cllr. Parker had considered and stated he had no objection and the Clerk submitted PC Support.

22/01381/HOU Mr & Mrs Greenleaf. The Mill House (2nd application)

Ground floor ss extension to boot room, new sash windows and door to kitchen. Mew roof light to 1st floor bedroom.

AP said that there was insufficient information to assess the application. e.g., no floor plans.

22/01305/PNHOU Khaya, Water Lane.

Addition of 1st floor above pt. of principle elevation. AP unhappy with this application, the application details were very poor.

Clerk to write to planning for further information.

WCC sent information for Mill House but ignored our request for Khaya.

8. COMMUNITY MATTERS/FACEBOOK – Cllr.McIntyre.

Melissa Simm was invited to speak, and she referred to the wildflowers which were established in the verge in front of the Church, unfortunately these kept being cut down when the grass was cut. She was looking at other possible areas with Nicola. The tree area at the end of the village was discussed as the grass was a problem with some residents. It was HCC land and not the Parish Councils. The area around the flagpole was discussed. NM thought that perhaps a group of residents could be used.

It was agreed that the area should be cut for Remembrance Sunday only. Leaflet to this effect for the notice board.

Last cut end of April at the Church by WCC but check with Cllr. Russell Gordon-Smith.

9.HIGHWAY MATTERS – Cllr. HUTTON.

Cllr. Hutton reported that some work had been carried out and the pothole at the Ford had been marked with white paint for repair.

10.LENGTHSMAN/SID – Cllr. Nankivell.

PN said that the lengthsmen had visited last week. Water Lane had been strimmed, the approaches to the ford and the tree branches at the 30mph sign. They will be back in two months' time.

SID - new pole purchased and invoice paid by Karl Borges. NM offered to store one pole.

AP stated that the Sun Lane Construction Plan was still awaited.

The Chairman referred to the large map of the village being laminated.

Fly tipping had been reported to HCC.

Jackie Sumner had sent an email re the condition of the Alresford footpath, low branches and nettles. Report to HCC Highways, from Mill Lane onwards.
