- The Dean Carpark - Business owners have signed their contracts with the developer. Like everyone, they are awaiting further information on the public consultation prior to the planning application. They have confirmed that they will pull out if this 3rd attempt at contracts falls through.
- Natural England have declared on phosphates as they did on nitrates and all planning applications have been stopped in several parts of the Winchester District. The River Itchen and the city are the two areas most impacted. The major difference versus nitrates is that mitigation must happen in the designated area not in any part of the District. Apparently officers think it will be two years before there is an agreed approach to the mitigation
- Bishop's Sutton footpath - The feasibility study has been completed and options are now being looked at with regard to what can be done with the 106 monies set aside. The cost of delivering the full enhanced path is above what any joint CIL application could apply for. I will update you once more is discussed.
- Litter pick 2022 - I was pleased to help once again, with the organised NATC Litter pick day. Fantastic helpers of all ages.
- Winchester road - 40-30mph campaign - Further information has gone onto HCC traffic team for consideration. Along with pictures of the abandoned highways lorry from Dorset, parking in the centre reservation area. The lack of visibility was ridiculous. I attempted to cross from Tichborne to turn right towards Alresford and you could not see traffic from the left. Evidence has been sent along with a call to the depo manager in Blandford asking them to rent a yard instead of parking in the lay-by . These vehicles are working in Dorset and are only being parked there because the driver lives in Itchen Abbas and does not have a car. After speaking with the Depot manager further, all the vehicles in the lay-by will now be parked in Winchester at another industrial yard.



- Further reports have been raised on the hedges into Itchen Abbas and also the sign before Little Hayes Lane



- Jacklyn's Lane requested reduction of hedge height - Residents requested help after the agreed height of the footpath hedge height was to be kept low for safety and security. Whilst both ends were cut, the middle was left. This area was where antisocial behaviour was and an assault. Hampshire have now confirmed to me that this will be reduced as agreed, once the nesting season has finished. This has been reported back to the residents who raised this issue.
- Fly tipping and burning of rubbish in an open residential parking area - Concerned residents asked for help in a matter relating to fly tipping and then burning of trash, in an open residential parking area. This has now been dealt with, the area cleared and the police are now keeping an eye on it.
- I have reported a number of drainage issues onto the HCC site, most of the missing drain covers and pavement issues have now been sorted.
- There are still issues of staffing vacancies across many businesses and at the same time concern over high electricity, gas and petrol costs. This in many ways makes it harder for our area as staff have to travel.
- Host 4 Ukrainians Hants - Like many people, I have been helping with some refugees trying to escape the dreadful time they are experiencing. I have been contacted by a number of residents, who would love to help but can't host.
