### 14. FOOTPATHS & ROW.

Cllr. Nankivell had nothing to report. This item was taken after Item 6 in order that Margot Power could outline her ideas on the Bishop's Sutton/Alresford footpath. The northern end of the footpath had tree roots obstructing it whereas the southern end had grass encroaching over it. This made it difficult for ladies with children's buggies and walkers. It was pointed out that it was worse on the Alresford side. Margot Power claimed that HCC Highways would fill in the potholes etc. if the Lengthsman could remove the grass and cut the path back to the normal width. However this was hard to imagine when Highways could not fill in the main road potholes.

The Chairman stated that the lead Parish Council Shedfield were investigating other contractors relating to the Lengthsman. The PC would discuss additional path maintenance with Shedfield PC. PN said that we should establish the width of the path.

The Chairman thanked Margot Power.

### 15. DEFIBRILLATOR.

RB gave details of how much had been collected. Alresford Pigs had RB generously donated £900, the Village Hall £500. Shoot Raffle £175 and £890.49 from local residents. RB explained how the equipment would be funded with Community Heartbeat Managed Solution. They will cover the insurance, theft, damage, paperwork, liaison with the ambulance service.
