

**MINUTES OF THE MEETING OF BISHOP'S SUTTON PARISH COUNCIL

9. INDUSTRIAL PLANNING AND LENGTHSMEN.

MJ outlined the developments at the Industrial Site in Old Park Road. New fencing and gates had been erected which are on Lady Vestey's land. WCC are going through the process of having them removed but this will take time.

10. RESIDENTIAL PLANNING.

17/03123/FUL Pilgrims, School Lane, Bishop's Sutton

Redevelopment to provide a detached chalet bungalow.

The Chairman stated that the new plans had been received.

The Clerk read out a letter from the Highways Engineer who stated that there had been no attempt to address the previous concerns and he maintained his objection to the application as did Mr & Mrs Dickinson next door to this property.

11. WEBSITE.

PN had spoken to Mark Allen and a new email address needs to be created which will cost around £34. PN will organise.

13. HIGHWAYS.

JS stated that the speed signs in the village were hidden by vegetation and this required cutting back. Clerk to report.

WCC are carrying out a parking strategy review.

A resident (Tony Catesby) had repainted the milestone in the village. Clerk to write and thank Tony.

MJ had been chasing HCC re the condition of the village hall joint residential entrance. Previously HCC stated that it was not their responsibility, however MJ had persuaded Engineers to visit the site before effecting a repair.

14. FOOTPATHS & ROW.

PN agreed that BS should have wildflower verges.

PR mentioned the Tree Appeal. One person has been added to the list who was killed in Korea which makes 15. He had spoken to Paul Vestey

and will contact Rob Humby at HCC. The location is hoped to be between the roundabout and Cobbs Farm. The trees will be Cherry trees with daffodils planted underneath and poppies and the planting will be around Armistice Day.

17. SUN LANE DEVELOPMENT – A31 JUNCTION.

WCC discussed the planning application on 21st June 2018 in the Guildhall. Clerk had contacted the public speaking co-ordinator. Graham Sumner spoke on behalf of the PC. MJ had produced three points to represent the PC case and these were put to the Committee who's Members asked questions afterwards. The Planning Committee approved the Outline Planning Application, however there is still a lengthy process to secure the legal agreements around the delivery. The new junction will be built first to ensure access is through the site and not through the town and it will take 18-24 months before the junction commences.

Members thanked Graham through Jackie.

A letter had been received from the railway company stating that they had not been consulted.
